(MANAGEMENT QUOTA ADMISSION: 2024-25)

Trinity Institute of Professional Studies, Sector -9, Dwarka, New Delhi announces the opening of Admissions under the <u>MANAGEMENT QUOTA</u> for BBA, BCA, BA(JMC), B.Com(H) programmes in both shifts & BA.LLB (H) in single shift for the Academic Session 2024-25, w.e.f. <u>12.07.2024</u>, as per the Notice No- GGSIPU/Academic/2024/494 & 495 dated 28.06.2024. The important information in this regard are as follows:

1. Eligibility: For BBA/ BCA/ BAJMC/ B.Com(H) admission aspirants, the Candidate who has appeared in the University CET and CLAT for BALLB(H), shall get preference over the candidate who wishes to take admission through CUET. Once the rank ordered Merit list (based on the marks in qualifying examination of the candidates) appeared in CET [For BBA, BCA, BAJMC, B.COM(H)] and CLAT [For BALLB(H)] gets exhausted then only the merit of the qualifying examination in respect of candidates who appeared in CUET will be considered.

Candidates are advised to kindly refer eligibility criteria as prescribed in the GGSIPU Admission Brochure for the Academic session 2024-25.

- 2. Process: The eligible/interested candidate may apply for management quota admission by taking the Application Form downloaded from the Institute's website or from the Reception of the Institute on any working day (Mon to Sat except Gazetted Holidays) between 09:00 AM to 05:00 PM and submit the complete application form along with the required documents (mentioned in point No. 4) in person at reception of the institute. Online Applications are also invited, the link is available on the Institute website, www.tips.edu.in/admission-mq
- **3. Registration & Counselling Fee:** Rs. 2500/- (non-refundable) per programme.
