IMPORTANT NOTICE

MANAGEMENT SEATS : MANDATORY ADMISSION PROCEDURE
FOR THE ACADEMIC SESSION 2024-25

Section 12 (1) (a) of the Delhi Professional Colleges or Institutions (prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitive Fee and other Measures to Ensure Equity & Excellence) Act, 2007 (Delhi Act 8 of 2007), states that in every Institutions, except the Minority Institutions subject to the provisions of this Act, 10% of the total seats in an unaided Institution shall be allocated as Management Seats.

Section 13 of the Delhi Professional Colleges or Institutions Act, 2007 states that "An institution shall, subject to the provisions of this Act, make admission through a Common Entrance Test to be conducted by the designated Agency, in such manner, as may be prescribed: Provided that the Management Seats may be advertised and filled up, from the candidates who have qualified the Common Entrance Test, by the Institution in a transparent manner based on the merit of the Qualifying Examination".

The Govt. of NCT of Delhi in exercise of powers conferred by Section 23 of the Act, 2007 has made Delhi Professional Colleges or Institutions Rules 2007. The details of Rule 8(2)(a) notified by Govt. of NCT of Delhi have also been made available in the Chapter-6 of the UG/PG Admission Brochure 2024-25.

Further, the Govt. of NCT of Delhi had also issued directions vide their Order No. DHE-4(4)/GGSIPU/2019/4674-76 dated 22.09.2022 for necessary compliance.

In pursuance to Govt. of NCT of Delhi Order No. DHE-4(4)/GGSIPU/2019/4674-76 dated 22.09.2022, the University had issued directions vide University's Notification No. 245/2022 dated 27.09.2022 for compliance by affiliated institutes/colleges.

The provisions of the Delhi Professional Colleges or Institutions (prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitive Fee and other Measures to Ensure Equity & Excellence) Act, 2007, Rules notified thereunder, Order issued by Govt. of NCT of Delhi vide their letter dated 22.09.2022 are to be implemented by the affiliated institutions/colleges for admission against Management Seats for all the programmes.

In addition to the above, the Hon'ble High Court of Delhi in the LPA No. 563-2023 and CM Appeal No. 3717-2023, 37180-2023, 37181-2023 and 40286-2023 in the matter of VIPS versus Govt. of NCT of Delhi and Anr. had pronounced judgement on 04.08.2023. the para 34 of the Judgement pronounced by the Hon'ble High Court vide Order dated 04.08.2023 is re-produced below: -

Para 34 "We hereby dispose of the present appeal upholding the following directions notified in the circular dated 22.09.2022 with partial modification that besides online mode, the candidates, shall also be eligible to apply in "offline mode" for management quota seats. The directions are as under:-

- i) GGSIP University to make an online portal to display the branch-wise college wise seats available under Management Quota.

- ii) Prospective students can apply online as well as offline against available seats under Management Quota.
- iii) The college shall display the list of aspirant admission seekers on the online portal as well as the notice board of the college.
- iv) The College shall prepare common merit wise list of candidates who have applied through online and offline mode.

It is further informed that the CM Appeal 40286/2023 in LPA 563/2023 was filed seeking amendments, modifications of direction of Judgement dated 04.08.2023 passed by the Hon'ble High Court of Delhi in the said LPA.

The Hon'ble High Court of Delhi in the CM Appeal 40286/2023 in LPA 563/2023 issued Order dated 07.08.2023 and para 9 and 10 of the order dated 07.08.2023 of the Hon'ble High Court of Delhi is re-produced below:

Para 9 With regard to first prayer seeking modification in Para-34 of the Judgement, this court finds that though this prayer is not maintainable, however, in view of the averments made therein, we hereby clarify that sub-clause (ii) of Para -34 of the judgement shall be read as under:

Prospective students can apply online on the portal of the institute as well as of line (in the prescribed form downloaded from the website of the college against receipt issued from the college) against available seats under management quota."


Para10. It is further clarified that the Chairman of the Management of the Appellant-Institute, shall file a compliance affidavit in terms of the Judgement dated 04.08.2023 passed by this court in the present appeal within four weeks.

The Rule 8(2)(a)(ii) notified by the Govt. of NCT of Delhi makes it mandatory for the affiliated institutes/colleges to publish Admission Notice Advertisement for Management Quota Seats in atleast two leading daily newspapers, one in Hindi and the other in English in addition to displaying the same on the institutions/colleges website.

It is also mandatory that the Admission Notice Advertisement shall be displayed atleast fortnight before the last date of closing of admission for the concerned course in the University and the said Admission Notice Advertisement shall include place from which application forms will be available, date and time for issue of applications, manner of submission of completed applications as well as schedule with dates for various admission processes and counselling.

It is for information of all the Affiliated Institutes/Colleges that the last date of closing of admission for the concerned course in the University for the purpose of implementing Rule 8(2)(a)(ii) will be intimated by the University and, therefore, the Affiliated Institutes/Colleges shall plan their schedule accordingly.

In view of the Judgment pronounced on 04.08.2023 and orders dated 07.08.2023 in the LPA 563/2023, the affiliated institutes are hereby directed to ensure compliance of the Orders of the Hon'ble High Court and compliance of the Delhi Professional Colleges or Institutions (prohibition of Capitation Fee, Regulation of Admission, Fixation of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence) Act, 2007 and the Rules notified thereunder during the Academic Session 2024-25.
